Program: Eric Rucker, former State Senator and Shawnee County Commissioner

Eric started as a car salesman and then became an attorney. He has served in various public service positions for 50 years.

He discussed the U.S. Supreme Court decision a few years ago that overturned

interpretation of the First Amendment applicable to educational programs. The First Amendment has three clauses: establishment of state religion prohibited, guarantees free exercise of religion and freedom of speech.

Schools were considered an arm of government due to federal and state funding. Starting in 1962, the U.S. Supreme Court prohibited school religious practice; in 1963 prohibited reading of the Bible; then prohibited state funding of religious schools; and in 1980 removed display of the Ten Commandments.

For 60 years, a three-prong test was used to determine whether a particular action was allowed in a school setting. With the U.S. Supreme Court decision, the Court recognized the difficulty applying the three-prong test and concluded that religious expression in public schools is not establishing a state religion but is a freedom of speech and free exercise of religion which are allowed by the First Amendment.

The test case involved a football coach praying silently on the 50-yard line after the game when players volunteered to join him. The school district fired him.






